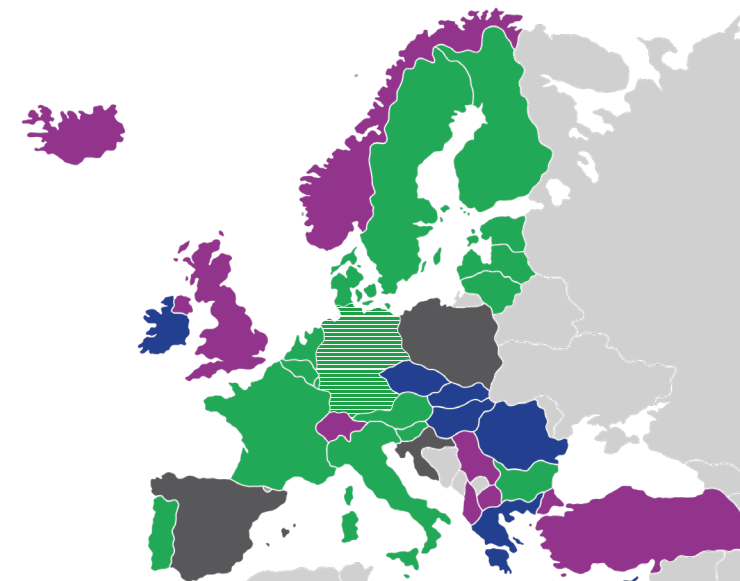

- The UP/UPC will apply only in Member States of EU that have signed and ratified the UPCA
- All Member States of EU have signed the UPCA except Spain, Poland and Croatia
- Of the 24 Member State signatories to the UPCA:
 - 16 have already ratified/ deposited the ratification instrument for the UPCA (including France, Italy, the Netherlands, etc.)
 - The UP/UPC will be in force in the 17 participating Members States from the start date
 - The UP/UPC will enter into force in the seven other Member States from the date they ratify/deposit the ratification instrument for the UPCA

- Member States of EU which have signed the UPCA but have not yet ratified/deposited the ratification instrument: **they will participate as soon as they ratify/deposit**
- Member States of EU which have ratified/ deposited the ratification instrument for the UPCA: **they will participate from the start date** (NB: Germany to deposit soon the ratification instrument to trigger entry into force of the UPC)
- Member States of EU which have not signed the UPCA (Spain, Poland, Croatia): **they won't participate**
- EPC non-Member States of EU (e.g., the UK, Turkey, Switzerland): **they cannot participate**
